- TREASURER'S REPORT: We currently have a total of \$16,248.75 in our General Checking Account, \$5,061.20 in our Legal Defense Fund and \$14,230.76 in our Money Market Account, for a total balance of \$35,540.71 We are managing the Los Liones Planting Project which has a total balance of \$3,888.63.

- THE CONDITION OF YOUR PROPERTY: Please keep your property clean and in good repair. According to the CC&R's, Article I, Section 7, lots are to be kept cleared of weeds and rubbish. The CMHO has the right at any time to enter upon the property of an owner who is not observing this restriction and remove weeds and rubbish and put the premises in a neat and orderly condition. The expense of cleaning up a property is due and payable from the owner to the CMHO. Also, it is a City regulation that your trash bins must be placed back on your property by 6 pm the night of trash pick-up. We live in a beautiful neighborhood and it is inconsiderate to your neighbors to leave your property in a neglected state.
- THE GETTY VILLA COMMUNITY RELATIONS COMMITTEE (GVCRC): As reported in the last newsletter, the GVCRC has recently decided to meet quarterly, instead of bi-monthly, as there are no pressing neighborhood issues.
- ARCHITECTURAL COMMITTEE REPORT-CURRENT PROJECTS: One of the CMHO's primary responsibilities, through your Architectural Committee (AC), is to uphold the CC&R's. Property owners are required, as per the CC&R's, to bring their construction projects, no matter how small, to the AC early in their process to save time and money. Article II, Section 6 of the CC&R's state, in part, "To help avoid inconvenience and needless expense to property owners the Architectural Committee shall...examine or discuss preliminary plans and render a tentative, non-binding opinion on their acceptability."

For owners and real estate agents <u>Architectural Guidelines</u> are available to assist property owners in planning their projects. They are available via the internet upon request. If you are interested, please ask Kim to email you a copy.

### Current projects:

- 1. 318 Bellino: At the request of the AC, the new owner will be submitting revised plans to mitigate some of the neighbor's concerns. Upon receipt of the new plans, the AC will follow its usual procedure.
- 2. 257 & 269 Bellino: Demolition of the two existing houses is underway on these lots. Preliminary plans have been submitted for two houses. The plans include an under floor space for each house. When plans are more complete the AC will continue its review process.
- 3. 17630 Tramonto: The owners are remodeling their master bedroom on the lower level. They plan to extend their current bedroom 3' out onto their existing deck. The AC is following its normal review process
